Ownership of the goods will not be passed to the customer until full payment is received.

All fire penetrations, fire rating and compliance certification is excluded.

All fire isolations, fire trip relays, fire trip interfaces and cabling is excluded.

Any patching and painting is excluded

Asbestos work, asbestos removal, or other dangerous or harmful substances is excluded.
